

**Revenue Estimating Conference**  
**Gross Receipts Tax / Communications Services Tax**  
**November 29, 2018**  
**Executive Summary**

The Revenue Estimating Conference met on November 29, 2018, to adopt a new forecast for the Gross Receipts Tax and the State Sales Tax on Communications Services. For FY 2018-19, projected collections for the Gross Receipts Tax (derived from the tax on electricity, gas and communications) were decreased \$28.07 million, and for State Sales Tax on Communications Services projections were decreased \$14.44 million from the previous estimates. Compared to the July conference results, the new forecast for both tax sources is lower throughout the forecast period. The changes in the Gross Receipts Tax feed directly into the dollars available for PECO appropriations. The State Sales Tax on Communications Services supports the General Revenue Fund. Conference highlights are detailed below.

**Gross Receipts Tax on Utilities...** Overall residential, commercial, and industrial electricity collections are tracking lower than FY 2017-18. The weakness is attributed to a combination of lower prices than previously expected as well as lower consumption due in part to the milder fall weather. The forecast going forward is expected to stabilize with lower prices for all three components and lower levels of consumption by residential and commercial users. Efficiency gains, changing consumption patterns, and more typical weather patterns, are significant factors leading to the changed expectations.

Residential consumption of natural gas is expected to be higher than assumed in the prior forecast. FY 2017-18 saw a spike in residential consumption relative to prior years. The Conference had expected a bounce back in FY 2018-19 to previous levels of consumption, but that has not materialized. The forecast has been adjusted to account for this higher level going forward. So far, commercial consumption has exhibited no growth from FY 2017-18, and the levels have been adjusted downward throughout the forecast. The forecast for natural gas prices has a smooth pattern tied to spot and future prices of natural gas for both the residential and commercial sectors.

**State Communications Services Tax, Including Direct-to-Home Satellite Service (CST)...** The overall estimates for Gross Receipts CST and Sales CST are built up from a lower level analysis. Essentially, the

forecast relies on generating separate growth rates for the cable, wireless, landline (residential and commercial), miscellaneous services and direct-to-home satellite tax bases.

The two primary positive drivers of growth in CST are the Cable and Other categories. Typically, despite the drop in subscribers, the cable forecast is buoyed by growth in the price of subscriptions. According to tax return data thus far, the cable forecast for the current year is anticipated to show no growth over the prior year. Going forward, the growth rates are slightly weaker than the prior forecast, and drop below 2.0% at the end of the forecast horizon. The second primary positive driver, Other, is expected to realize most of its growth through streaming entertainment gains. This category is expected to grow 10.66% in the current year. Thereafter, the growth rates gradually diminish to a still strong 3.09% ten years out. The Wireless and Landline forecasts counter the positive growth seen in Cable and Other. Wireless has been declining in large part due to unbundling of communication services tied to cellphone plans. The declines continue throughout the forecast, but are greater in the near term. These expectations essentially match the prior forecast. Landline usage is declining due to dated technology and changing behavior; the category is expected to drop -7.58% in the current year and then slow to a -2.21% decline in the last year, largely matching the prior expectations. On the other hand, Satellite, or DHSS, has a detectably lower forecast. The first year has negative growth of -3.58%. While growth becomes positive thereafter, the growth rates steadily decline from 2.62% to 2.00%. The prior forecast was more stable over the long term.

Gross Receipts CST is derived from two different tax rates plus a portion of direct-to-home satellite collections. First, a tax rate of 2.37% is applied to the cable, wireless, landline and miscellaneous services tax bases. Second, an additional tax rate of 0.15% is applied to the same tax bases, excluding landlines in residential households. The dollars generated by both of these tax rates, plus 18% of total direct-to-home satellite collections, comprise total Gross Receipts CST collections.

The tax rate for Sales CST is currently set at 4.92%. Sales CST Collections are generated by applying the tax rate against the cable, wireless, landline and miscellaneous services tax bases, coupled with 44.32% of total direct-to-home satellite collections. The landline tax base is reduced by the residential household telephone exemption for Sales Tax CST. Because the weakening landline base impacts Gross Receipts CST to a greater degree than Sales CST, Sales CST has stronger growth rates.

The tax rate for direct-to-home satellite service is currently set at 11.44%. The tax revenue is distributed between Gross Receipts CST, Sales CST, and local governments.

**Local Communications Service Tax...** The local CST forecast applies an average local CST tax rate of 5.0% to the four major bases (cable, wireless, landline and miscellaneous services). Like the CST forecasts for Gross Receipts and Sales, the local forecast is expected to decline because of the reduction in the wireless base.
