Gross Receipts Tax/Communications Services Tax
March 1, 2019
Executive Summary

The Revenue Estimating Conference met on March 1, 2019, to adopt a new forecast for the Gross Receipts Tax and the State Sales Tax on Communications Services. For FY 2018-19, projected collections for the Gross Receipts Tax (derived from the tax on electricity, gas and communications) were decreased \$1.16 million and for State Sales Tax on Communications Services projections were decreased \$2.09 million from the previous estimate. Compared to the November conference results, the new forecast for the Gross Receipts Tax is lower throughout the forecast period. Ensuing years face a general decline from earlier projections across most of the component parts; the small portion of the new forecast attributable to natural gas was an exception. Likewise, the Communication Services Tax projections were slightly reduced or held the same across all elements of the tax base. The highlights are detailed below. Only the changes in the Gross Receipts Tax feed into the dollars available for PECO appropriations.

Gross Receipts Tax on Utilities... Residential electricity prices are expected to decline both this year and the next, before resuming modest growth that comes in slower than the prior forecast. Conversely, residential consumption is expected to exhibit a growth pattern that is very similar to the old forecast. In general, these patterns also hold for electricity used for commercial and industrial purposes. As a result, collections related to electricity are a drag on the total.

For natural gas, residential prices are overall stronger, but consumption declines in FY 2018-19 and does not fully recover to the prior forecast over the following years, despite modestly stronger growth rates. However, the stronger prices and little-changed consumption patterns for commercial use help push collections related to natural gas to a positive position relative to the prior forecast. Because natural gas is such a small component of the total Gross Receipts Tax, the strength here does not compensate for the weakness elsewhere.

State Communications Services Tax, Including Direct-to-Home Satellite Service (CST)... The overall estimates for Gross Receipts CST and Sales CST are built up from a lower level analysis. Essentially, the

forecast relies on generating separate growth rates for the cable, wireless, landline (residential and commercial), miscellaneous services and direct-to-home satellite tax bases.

The two primary positive drivers of growth in CST are the Cable and Other categories. Typically, despite the drop in subscribers, the cable forecast is buoyed by growth in the price of subscriptions. According to tax return data thus far, the cable forecast for the current year has now turned negative, suggesting -0.98% growth for the year, and continues to be slightly weaker going forward. The second primary positive driver, Other, is expected to realize most of its growth through streaming entertainment gains. This part of the forecast was left unchanged.

Similarly, the Wireless and Landline forecasts were also unchanged with year-to-date activity essentially matching prior expectations. Wireless has been declining in large part due to the unbundling of communication services tied to cellphone plans. Landline is similarly declining, but due to dated technology and changing behavior. In contrast, the forecast for Satellite, or DHSS, was reduced relative to the prior forecast. While the overall pattern is similar, the decline in the first year has deepened and the growth rates going forward are slightly weaker.

Gross Receipts CST is derived from two different tax rates plus a portion of direct-to-home satellite collections. First, a tax rate of 2.37% is applied to the cable, wireless, landline and miscellaneous services tax bases. Second, an additional tax rate of 0.15% is applied to the same tax bases, excluding landlines in residential households. The dollars generated by both of these tax rates, plus 18% of total direct-to-home satellite collections, comprise total Gross Receipts CST collections.

The tax rate for Sales CST is currently set at 4.92%. Sales CST Collections are generated by applying the tax rate against the cable, wireless, landline and miscellaneous services tax bases, coupled with 44.32% of total direct-to-home satellite collections. As part of the calculation, the landline tax base is reduced by the residential household telephone exemption for Sales Tax CST. Because the weakening landline base impacts Gross Receipts CST to a greater degree than Sales CST, Sales CST has moderately stronger growth rates.

The tax rate for direct-to-home satellite service is currently set at 11.44%. The tax revenue is distributed between Gross Receipts CST, Sales CST, and local governments.

Local Communications Service Tax... The local CST forecast applies an average local CST tax rate of 5.0% to the four major bases (cable, wireless, landline and miscellaneous services). Like the CST forecasts for Gross Receipts and Sales, the local forecast is expected to decline over time due to the reduction in the wireless base. Relative to the prior forecast, the negative growth rates expected in both the current year and the next have intensified and a third year of decline has been added before growth—albeit weaker—reappears.
