**Executive Summary**

Overall, revenue collections from Highway Safety Licenses and Fees (HSMV) during the first one-third of the 2013-14 fiscal year were somewhat higher than projected when the updated estimates were adopted back on July 29, 2013. As a result, the new HSMV forecast showed areas of detectable improvement over the July forecast; however the net changes by fund were fairly modest.

Revisions to the forecast for nine revenue categories—representing most of the larger categories—were positive throughout the forecast period. Changes to the estimates for another five revenue categories were mixed, including increases, decreases, and / or no changes to the prior estimates depending on the year. Finally, projected revenues for six revenue categories, primarily relating to red light cameras, transcripts and records, commercial driver licenses, reinstatements and DUIs, were adjusted downward relative to the previously adopted estimates.

The revised estimates by category resulted in increased revenues over the previous forecast for the General Revenue Fund and the State Transportation Trust Fund, and slightly lower revenues for the Highway Safety Operating Trust Fund. The revisions are shown below:
