Executive Summary
March 10, 2017 – Updated for Post 2017 Session

Measures Affecting Revenue: 2017 Session Actions...The March 10, 2017 State Transportation Trust Fund estimates have been updated to reflect law changes passed during the 2017 Regular Legislative Session. In conjunction with each session of the Legislature, the Revenue Estimating Conference (REC) meets as an Impact Conference to assess the fiscal impact of legislation affecting state revenue collections. Sometime after the end of each session, the REC adopts the official Measures Affecting Revenue, which include the impact of legislation by source. Legislation from the 2017 Regular Session affected State Transportation Trust Fund collections by -\$0.1 million in each fiscal year of the forecast, beginning in FY 2017-18.
