

# National Economic Estimating Conference

## February 10, 2017

The National Economic Estimating Conference met on February 10, 2017, and adopted the IHS Global Insight baseline forecast. Since the last conference, real gross domestic product (GDP) data shows that GDP grew at an annualized rate of 3.5 percent during the third quarter of 2016, the fastest rate since the third quarter of 2014. Fourth quarter GDP grew at an annualized rate of 1.9 percent. Volatility in soybean exports slowed growth in the fourth quarter. The forecast estimates GDP growth at 2.1 percent in the first quarter of 2017 and similar growth in the second quarter of 2017. In total, GDP is expected to grow 2.0 percent in Fiscal Year 2016-17 and 2.5 percent in Fiscal Year 2017-18.



The new baseline forecast is consistent with the November adopted forecast and continues to show growth in the US economy. Relative to November, it is slightly stronger overall, although current declines in utilities, motor vehicles and machinery production will restrain growth slightly. As noted in the Executive Summary produced by IHS Global Insight, the February baseline forecast assumes no trade wars and no serious policy mistakes in the coming year. The forecast incorporates estimates for income tax cuts and a federal government hiring freeze exempting military, public safety and public health employees, but does not incorporate policy changes such as immigration reforms, tariffs and border adjustment taxes into the forecast.

Further, although policies to boost investment are being discussed at the national level, the baseline forecast does not incorporate the new incentives to boost capital spending into the forecast. The baseline forecast assumes that the pace of recovery will pick up in 2018 as the expected fiscal stimulus from personal income and corporate income tax cuts kick in.

Employment continues to show positive gains, with the forecast expecting a growth rate of 1.6 percent in Fiscal Year 2016-17, slightly above the November forecast. The unemployment rate also continues to show improvement. The unemployment rate is expected to decline to 4.7 percent during Fiscal Year 2016-17, falling to 4.1 percent in Fiscal Year 2018-19 and 2019-20 before rising back up to 4.6 percent in the long run — a decrease since the last forecast.

After a robust second and third quarter, consumer spending is expected to increase 2.9 percent in Fiscal Year 2016-17 and 2.9 percent in Fiscal Year 2017-18, as a slowdown in motor vehicle purchases is offset by increased energy consumption. Housing starts in the fourth quarter grew at the fastest pace in six quarters and the strongest annual rate since 2007. Starts are expected to grow at a rate of 4.4 percent during Fiscal Year 2016-17 and 6.6 percent during Fiscal Year 2017-18.

The trajectory of the Federal Funds Rate shows a gradual increase in rate hikes over the next several years, finally reaching 3.0 percent in Fiscal Year 2020-21. Lastly, the outlook for corporate profits over the next few years continues to be positive with profits increasing by 11.5 percent in Fiscal Year 2016-17 and 4.5 percent in Fiscal Year 2017-18.
