Executive Summary

The forecast for Documentary Stamp Tax collections has not been changed since the April 11, 2005 forecast. The projected total collections are shown below.

Three bills had an impact on the distribution of Documentary Stamp Tax Collections. SB360 designated distributions of \$750 million, which previously went into the General Revenue Fund, to be used for specified growth management infrastructure needs, beginning in 2005-06. SB2600 (the General Appropriations Act) provided for additional bond sales for the Florida Forever and Everglades Restoration programs, further reducing distributions to General Revenue, by \$9.4 million in 2004-05 and by \$36.3 million on a recurring basis. Finally, HB1889 provided for caps on certain trust fund distributions beginning in 2007-08, with the receipts exceeding those caps being designated for the General Revenue Fund.
