# Education Estimating Conference on Student Financial Aid EXECUTIVE SUMMARY July 14, 2014

The Student Financial Aid (SFA) Estimating Conference met on July 14, 2014, to adopt estimates for FY 2014-15 through FY 2017-18 for the new Florida National Merit<sup>®</sup> Scholar Incentive Program.

Section 26 of Chapter 2014-56, L.O.F., creates section 1009.893, Florida Statutes, which establishes the Incentive Program to reward Florida high school graduates who receive recognition as a National Merit<sup>®</sup> Scholar or a National Achievement<sup>®</sup> Scholar. The award is equal to the cost of attendance (including tuition and fees, room and board, and other expenses) at a public postsecondary educational institution, minus the amount of the student's Bright Futures Scholarship and National Merit<sup>®</sup> Scholarship or National Achievement<sup>®</sup> Scholarship.

The Conference adopted a series of assumptions (detailed on the *Consensus Estimate*) in order to generate a forecast for the number of eligible students as well as the estimated appropriation that would be required to provide a full award to all eligible students. Adopted estimates are as follows:

- 4. The number of Florida Scholars attending a Florida postsecondary institution is expected to increase significantly (21.5%) during FY 2015-16, with more moderate increases thereafter.

- 6. Although the renewal rate for initial FAS students is 90%, initial students for this program are assumed to renew at a higher rate.

- 1. Section 26 of Chapter 2014-56, L.O.F., creates the "Florida National Merit<sup>®</sup> Scholar Incentive Program."
- 2. The scholarship rewards Florida high school graduates who receive recognition as a National Merit<sup>®</sup> Scholar or a National Achievement<sup>®</sup> Scholar.
- 3. To be eligible for an initial award, a student must meet the following criteria:
  - a. Initially enroll in the 2014-15 academic year or later in a baccalaureate degree program at an eligible Florida public or private postsecondary educational institution.
  - b. Be a Florida resident.
  - c. Earn a standard Florida high school diploma or its equivalent; complete a home education program; or earn a high school diploma from a non-Florida school while living with a parent on military or public service assignment outside of Florida.
  - d. Be accepted by and enroll in a regionally accredited public or provide postsecondary educational institution in Florida.
  - e. Enroll full-time (minimum 12 credit hours per term) in a baccalaureate degree program during the fall academic term following high school graduation.
- 4. To be eligible for a renewal award, a student must meet the following criteria:
  - a. Earn all credits for which enrolled.
  - b. Maintain a 3.0 or higher grade point average.

#### 5. The award:

- a. Is equal to the public institutional cost of attendance minus the sum of the student's Bright Futures Scholarship and National Merit<sup>®</sup> Scholarship or National Achievement<sup>®</sup> Scholarship.
- b. May be prorated if the funds appropriated are not adequate to provide the maximum allowable award.
- c. May not be used for remedial coursework or developmental education.
- Chapter 2014-51, L.O.F. (General Appropriations Act) appropriates \$2.9 million in Specific Appropriation 70C to fund the program in FY 2014-15. Based on the FY 2014-15 average cost of attendance at a state university, the appropriation will provide approximately 182 scholarships.
