

## Public Schools PreK-12 Education Estimating Conference Executive Summary

July 7, 2016

The Public Schools PreK-12 Education Estimating Conference met on July 7, 2016, to adopt a PreK-12 Full-Time Equivalent (FTE) enrollment forecast through Fiscal Year 2021-22. The data updates included in this forecast are the 2015-16 Fourth Calculation, information related to the 2015 provisional births, and the Tax Credit Scholarship enrollment from the June Quarterly Report.

Overall, the new forecast for 2017-18 and beyond is slightly higher when compared to the February 2016 Conference forecast. Most of the increase is a result of a higher 2015-16 Fourth Calculation with stronger grade progression ratios than the Third Calculation. Another noteworthy difference between the February 2016 Conference forecast and July 2016 Conference forecast is the inclusion of certain adjustments from the adopted June 2016 Capital Outlay FTE forecast.

As a general caution, FTE enrollment data for 2013-14 forward are not comparable to prior years. This is due to the use of recalibrated FTEs as required by the 2013 statutory change described below.

### ***Comparison to Prior Forecast...***

The new 2017-18 PreK-12 FTE enrollment forecast is 5,464.36 FTE higher (0.19%) than the forecast adopted in February 2016. The increase is primarily due to higher grade progression ratios as a result of an increase from the 2015-16 Third Calculation to the 2015-16 Fourth Calculation.

Table 1 on the following page shows a summary of the forecast by program category, while Table 2 displays total FTE enrollment by year, and Table 3 illustrates the differences between the February 2016 and July 2016 forecasts.

### ***Key Assumptions, Analysis and Trends Underlying the New Forecast...***

- FTE Capped at 1.0 --- Beginning with the 2013-14 fiscal year, the statutes required that a student's FTE be capped at 1.0 or "recalibrated". There is an exception for summer instruction provided through the Department of Juvenile Justice, as well as a requirement that Florida Virtual School (FLVS) part-time (PT) courses held on school campuses be reported by the school district with a commensurate FTE allocation. This new way of calculating FTE produces greater uncertainty in the forecast.
- Tax Credit Scholarship Program --- For the July 2016 Education Estimating Conference, Tax Credit Scholarships were updated for the 2015-16 June Quarterly Report. The 2015-16 Tax Credit Scholarship data show an increase in the number of scholarships.

**General Notes...**

The Education Estimating Conference for Public School Enrollment forecasts full-time equivalent (FTE) students whose educational instruction is funded through the Florida Education Finance Program (FEFP). There are ten program categories in two groups:

Group 1

- Three for basic education students who are not exceptional education students (101: for PreK through Grade 3; 102: for Grades 4 through 8; 103: for Grades 9 through 12) and
- Three for basic education exceptional educational students by grade grouping (111, 112, and 113).

Group 2

- One for English Language Learners (130),
- Two for exceptional education students who need higher levels of services (254, 255) and
- One for students taking career education instruction (300).

The funded educational time for a student may be in a single program category or spread through two or more program categories.

The FEFP is calculated five times throughout the year to arrive at each year's final appropriation. Each calculation ("calc") uses the latest information regarding the number of students that is available:

- (1) First Calculation (1<sup>st</sup> Calc) – This calculation is completed immediately after the annual legislative session. FTE student enrollment is the forecast used by the Legislature for the General Appropriations Act.
- (2) Second Calculation (2<sup>nd</sup> Calc) – This calculation is made upon receipt of the certified tax roll from the Department of Revenue. FTE student enrollment is the forecast used by the Legislature for the General Appropriations Act.
- (3) Third Calculation (3<sup>rd</sup> Calc) – This calculation includes the July and October actual FTE surveys and the February and June estimated FTE. It is available in November.
- (4) Fourth Calculation (4<sup>th</sup> Calc) – This calculation includes July, October, and February actual FTE surveys and the June estimated FTE. It is available in March.
- (5) Final Calculation – This calculation includes the actual final FTE surveys for all four counts (July, October, February, and June) and is available in September or October of the next fiscal year.

'PreK' figures include only pre-school age children with disabilities (ESE) and pre-school age children whose parents are in the Teenage Parent Program. It does not include children participating exclusively in the Voluntary Prekindergarten Program who receive those services through the public school system.
