General Revenue Collections for March 2007

General Revenue (GR) collections for March 2007 were \$48.9 M under the General Revenue Estimating Conference (GR REC) estimates adopted at the March 12, 2007 conference. Sales Tax GR was \$47.8 M under estimate for the month. Five of the six components of Sales Tax fell under estimate. Consumer Non-Durables were under estimate by \$17.9 M (3.6%), Tourism under by \$14.0 M (3.9%), Automobiles under by \$9.3 M (3.0%), Business under by \$11.3 M (3.2%), and Other Durables under by \$0.4 M (0.3%). The Building component was \$1.0 M (0.9%) over estimate for the month. Total collections were under estimate by \$51.9 M for the month and \$34.6 M for the year to date. (The actual distribution to Sales GR was \$17.3 M more than the Sales Tax GR estimate used in the March GR REC, accounting for the discrepancy between month and year to date.)

Notable sources under estimate for the month include Corporate Income

Tax (CIT) and Refunds. Corporate Income Tax was \$25.3 M under estimate for the month, which may indicate that CIT estimated payments are being adjusted downward. Refunds in Corporate Income Tax were \$6.6 M over estimate, again indicating adjustments in final liability for the CIT. An overestimate in Refunds reduces the Net GR bottom line. Other small sources under estimate were within normal margins of error.

Sources notably over estimate for the month include the Documentary Stamp Tax transfer to GR, which was \$22.9 M over estimate, with underlying collections in the Documentary Stamp Tax running \$6.1 M over estimate for the year. Interest Earnings also exceeded estimate for the month, coming in \$9.3 M over estimate. Service Charges to GR were over estimate by \$4.0 M primarily due to the overage in Documentary Stamp Tax. To summarize, Net GR collections for March were \$48.9 M under the new March 2007 estimate and \$39.5 M under estimate for the 2006-07 fiscal year to date.
