

August 2000 GENERAL REVENUE COLLECTIONS FOR JULY

General Revenue (GR) collections for July were \$33.9 M under estimates adopted at the April 2000 Revenue Estimating Conference (REC) adjusted for law changes from the 2000 Regular Session. Preliminary Sales Tax GR was \$8.4 M over estimate for the month. (Distributions are made from total Sales Tax Collections to local governments, the Solid Waste Management Trust Fund, and various sports facilities as well as to the General Revenue Fund. Beginning this year, revenue sharing with municipalities and counties will also be distributed from total Sales Tax Collections rather than from Cigarette Taxes, Intangibles Taxes, and Pari-mutuel Taxes.) Other sources over estimate for July include: Intangibles Taxes, with the GR share \$6.4 M over for the month and total collections in this

source almost \$13.0 M over for the month, continuing to reflect last year's stock market performance; Beverage Taxes, \$4.0 M over for the month (this source includes the GR portion of both the Beverage Excise Tax and the By-the-Drink Tax); and Medical Hospital Fees (primarily counties reimbursing the State for nursing home expenditures for Medicaid patients), \$3.2 M over estimate for the month.

On the other hand, two sources primarily accounted for the belowestimate revenues for July: Estate Tax fell \$16.1 M under estimate; and Refunds were \$19.7 M over estimate (overages in Refunds reduce Net GR). Estate Tax collections historically have no set monthly pattern. Refunds partially reflect Insurance Premium refunds in the current year stemming from activity in the prior fiscal year. Service Charges and Other Taxes and Fees (both sources composed of many transfers to GR from all departments) were both below estimate, probably based on timing of transfers as agencies adapted to a new account code structure that began this fiscal year. Also, Corporate Income Tax missed the estimate by \$3.8 M, continuing its below-estimate performance from last fiscal year. This slowdown may reflect the Federal Reserve's previous increases in interest rates.

Overall, Net GR collections for July were \$33.9 M under estimate for the month and for the fiscal year. All estimates in the table below are based on the General Revenue Estimating Conference that met on April 7, 2000 as adjusted for law changes from the 2000 Regular Legislative Session.
