## **Preliminary General Revenue Collections for November 2004**

Preliminary General Revenue (GR) collections for November 2004 were \$45.1 M over the estimates adopted on November 12, 2004. Preliminary Sales Tax GR was \$24.5 M (about one-tenth of one percent) under estimate for the month. Although the Documentary Stamp Tax transfer to GR was \$11.3 M under estimate this month, total collections for Documentary Stamp Tax remain strong at \$46.0 M over the new estimate. It is expected that next month's transfer to GR will compensate for this month's shortfall. The estimate for Documentary Stamp Tax collections was significantly increased at the November GR conference. Interest Earnings fell \$2.3 M under estimate, continuing recent trends. Refunds fell well short of the estimate, but shortfalls in this source add to Net General Revenue.

Most sources were over estimate for the month. Corporate Income

Tax was \$11.8 M over estimate in a relatively small month for receipts. Insurance Premium Tax was \$16.0 M over estimate, primarily from the 2% Premium Tax portion. Surplus Lines receipts are also running well ahead of estimates. Medical Hospital Fees, counties' reimbursements to the State for expenditures on nursing homes, came in \$9.2 M over estimate, as counties caught up with payments due. Service Charges to GR, transfers from trust funds, were \$9.8 M over estimate, with the overage coming from the Documentary Stamp Tax Service Charge and Other Service Charges, a collection of smaller transfers from many different departments' and agencies' trust funds. Estate Tax was \$7.0 M over estimate for the month, although revenue from this source is always quite variable from month to month. Intangibles Taxes were over estimate by \$4.5 M, virtually all

due to the C portion of the tax that reflects refinancing.

To summarize, Net GR collections for November were \$45.1 M over the November 2004 estimate for the month and \$32.3 M over the November 2004 estimate for the fiscal year to date. All estimates in the table below are based on the General Revenue Estimating Conference that met on November 12, 2004, adjusted for law changes made by the 2004 Legislature.
