General Revenue Collections for June 2002

General Revenue (GR) collections for June were \$61.2 M over the estimate adopted at the March 8, 2002 Revenue Estimating Conference (REC). For the fiscal year, GR was over the March estimate by \$140.6 million. The Cor-

porate Income Tax and Intangibles Taxes account for the bulk of this month's good performance.

General revenue Sales Tax collections in June were \$0.9 M under estimate-essentially right estimate--for month, and ended the fiscal year \$15.4 M under estimate. Total collections in both Documentary Stamp Tax and Intangibles Taxes ended the year above estimates, which was reflected in transfers to GR. Documentary

Stamp Tax ended the fiscal year \$23.6 M over estimate; Intangibles Taxes ended \$37.6 M over estimate. Corporate Income Tax beat the estimate by \$118.9 M for the fiscal year, with a strong June performance. Insurance Premium Taxes showed strength, ended the fiscal year \$22.9 M over estimate.

On the flip side, sources falling under the estimate for the fiscal year were Estate Tax, Other Taxes and Fees, and Service Charges. Re-

funds ended the year over the estimate by \$4.4 M, which decreases Net GR.

To summarize, Net GR collections for June were \$61.2 M over estimate for the month and \$140.6 M over estimate for the fiscal year.
