Preliminary General Revenue Collections for May 2005

Preliminary General Revenue (GR) collections for May 2005 were \$95.9 M over the estimates adopted on April 11, 2005. Preliminary Sales Tax GR was \$24.6 M over estimate for the month. For the year to date, Sales $\ensuremath{\mathsf{GR}}$ is virtually on estimate, over by \$0.8 M. Other sources significantly over estimate for the month include this year's perennial over-achievers. Corporate Income Tax came in \$32.4 M over for the month, and now stands \$92.0 M over for the fiscal year. Documentary Stamp Tax, with total collections over estimate by \$65.5 M and the transfer to GR over estimate by \$10.0, continues to reflect the strong real estate market. (Service Charges to GR shared the wealth, coming in \$7.1 M over estimate with \$3.1 M due to Documentary Stamp Tax revenue.) Intangibles Taxes, especially Intangibles C that largely tracks obligations secured by liens on Florida realty, were \$15.1 M over estimate for the month, running \$27.5 M ahead for the fiscal year. In addition to the usual suspects, Insurance Premium Tax GR was over estimate by \$12.4 M this month, due to a larger than expected transfer to GR from the 2% Premium Tax. Finally, Interest Earnings were \$13.7 M over estimate this month.

Six sources were under estimate this month. Of those, only three continue to run under estimate for the fiscal year. Pari-mutuel Taxes were \$1.9 M under for the month and stand \$4.0 M under estimate for the fiscal year to date. An additional transfer to GR expected in June should bring the source up to estimate. Medical Hospital Fees were \$5.4 M under estimate; these fees are reimbursements from counties to the state for expenditures, primarily for nursing homes. This source is somewhat volatile from month to month. Corporate Filing Fees, primarily annual report and filing fees for Florida businesses, was \$4.1 M under estimate for the month and \$4.8 M under for the fiscal year to date. This estimate was increased by \$11.4 M at the April General Revenue Estimating Conference. Increased filing through the internet option may have skewed the monthly pattern for

this source. Refunds were over estimate this month by \$5.9 M, virtually all from Corporate Income Tax refunds, which reduces Net GR. Although Drivers License Fees were under estimate by \$5.2 M for the month, the source is over estimate by \$4.4 M for the fiscal year to date. As with last month when the source was significantly over the monthly estimate, this month's shortfall was due to timing of distributions to other trust funds.

To summarize, Net GR collections for May were \$95.9 M over estimate for the month and \$172.0 M over estimate for the fiscal year to date. All estimates in the table below are based on the General Revenue Estimating Conference held April 11, 2005. At that conference, the estimate for FY 2004-05 (current year) was increased by \$1,053.9 M. Specific results from that conference are available at http://www.state.fl.us/edr/.
