Revenue Estimating Conference Pari-Mutuel Revenues Executive Summary July 30, 2024

The Revenue Estimating Conference reviewed Pari-Mutuel revenues on July 30, 2024. For FY 2023-24, total collections came in at \$25.2 million. This was \$0.8 million or 3.3% above estimate.

Currently, the largest component from this collection of taxes, licenses, and fees is Cardroom Gross Receipts. Total collections from Cardroom Gross Receipts were \$0.4 million higher than anticipated in January 2024, leading the Conference to make similar-sized adjustments to each year of the forecast. The other revenue sources affecting the Pari-Mutuel Wagering Trust Fund were also adjusted to recognize year-end performance. Collections in FY 2023-24 from Table Fees totaled \$1 million, a gain of \$0.1 million to the estimate for the year. To account for this increase, the forecast was adjusted by \$0.1 million annually beginning in Fiscal Year 2024-25. Daily License Fees and Occupational Licenses & Fees were treated similarly, but not all years were affected due to rounding.

The Other Pari-Mutuel Tax category matched its estimate of \$0.7 million; however, due to the increase in Gross Receipts, there will be a reduction in Other Pari-Mutuel Tax collections that is associated with the HISA Tax Credit. Accordingly, the forecast for Other Pari-Mutuel Tax has been adjusted downward to \$1.1 for FY 2024-25, \$0.6 for FY 2025-26, and \$0.5 for each outer year. In total, Pari-Mutuel revenues are forecasted to be \$26.1 million in FY 2024-25, \$25.7 million in FY 2025-26, \$26.3 million in FY 2026-27, \$26.8 million in FY 2027-28, \$27.3 million in FY 2028-29, and \$27.7 million in FY 2029-30.

Note that this Conference package was first developed at the July 2023 Conference. Previously, parimutuel revenues were reviewed as part of the General Revenue Conference. The table below accounts for all revenues (other than slots) associated with activities at licensed pari-mutuel facilities.
