(A) The funds available figures are not adjusted for any future financial obligation related to the constitutional funding requirement for tobacco education and prevention. The amount of the future financial obligation is estimated to be \$90.0 million for FY 2025-26; \$91.9 million for FY 2026-27; \$94.2 million for FY 2027-28; \$96.2 million for FY 2028-29; and \$98.3 million for FY 2029-30.
